## Fresh Passport for a Newborn Child

Note : Take a printout of this checklist form and tick the documents enclosed in your application, put your name, signature and date at the bottom

FIRST STEP (REGISTRATION OF BIRTH / BIRTH CERTIFICATE): The child must be first registered as an Indian Citizen. For details please (Add the Consular Link)

**NOTE:** For a child born in Oman to be registered as an Indian citizen, the application must be made within one year of the child's birth on the prescribed form. At least one of the child's parents must be an Indian citizen at the time of applying.

**SECOND STEP (APPLICATION FOR PASSPORT):** Following documents are needed to apply for fresh passport to a new born child:

•	Printed copy of the duly filled passport application form at	
	https://mportal.passportindia.gov.in/gpsp. (Applicant should sign at appropriate	
	places on the first and last page of the application).	
•	02 recent photographs of size 2-inch x 2-Inch (51mm x 51mm) (one pasted on the	
	designated place in the application form and other to be attached application	
	form). application forms with photo of wrong specifications would be rejected.

	o Photographs should be recent (within six months) in dark colour, against	
	white background	
	o Photograph should have a frontal view, with both ears and chin to	
	forehead being visible	
	o Eyes should be open	
	o There should not be any distracting shadows on the face or on the	
	background	
	<ul> <li>Head coverings are not permitted except for religious reasons, but the</li> </ul>	
	facial features from bottom of chin to top of forehead and both edges of	
	the face must be clearly shown	
•	Procedure as mentioned above in First Step for registration of child as an Indian	
	citizen be followed and separate set of documents may be attached as	
	mentioned above.	
•	Copy of Birth Certificate issued by the Embassy of India Muscat and local Oman

•	Self-attested copies of parent's passports and residence permits / visas.
