Checklist For Self-Declaration for Proceeding on Leave Sultanate Oman to India

- **Passport Copy**
Self-attested photocopies of the front and last pages of the passport (personal information pages) must
- **Travel Documents**
Copies of confirmed round-trip air tickets must be provided.
- **Immigration Stamps**
Copies of the passport pages showing entry and exit immigration stamps must be submitted.
- **Medical Documents**
Original medical documents along with photocopies must be submitted as supporting proof for proceeding on leave.

Bereavement Cases:

If the leave is due to the death of an immediate family member, a government-issued death certificate must be submitted instead of medical documents.

Notes:

- **Validity of Documents**
Ensure that all passports and Oman Resident Cards are valid (not expired) at the time of submission.
- **Original Documents for Verification**
All original documents must be brought to the center for verification. Photocopies alone will not be accepted.
- **Mandatory Physical Presence**
All individuals required to sign the affidavit must visit the center in person and sign in front of the concerned officer.
