CHECKLIST FOR FATHER SENDING AND BRINGING HIS MINOR CHILD WITH THE PERSON KNOWN TO HIM

- **Father's Documents**
Original passport and Oman Resident Card, along with clear photocopies of both. Person who travels with **the child, his/her passport copy and photograph**
- **Accompanying Person**
Passport copy and one recent photograph of the individual traveling with the child.
- **Child's Documents**
Copy of the child's passport and one recent photograph.
- **Mother's No Objection Certificate (NOC)**
 - If the mother is residing in India:
The NOC must be notarized and signed by a Gazetted Officer.
 - If the mother is residing in another country:
The NOC must be attested by the Indian Embassy/Consulate in the respective country.
 - **Self-attested copy of mother's passport must be submitted.**
 - **In case of Death: A government-issued death certificate must be submitted.**
 - **In case of Divorce: A court-issued divorce decree must be submitted.**

Notes:

- **Validity of Documents**
Ensure that all passports and Oman Resident Cards are valid (not expired) at the time of submission.
- **Original Documents for Verification**
All original documents must be brought to the center for verification. Photocopies alone will not be accepted.
- **Mandatory Physical Presence**
All individuals required to sign the affidavit must visit the center in person and sign in front of the concerned officer.
