**CHECK LIST FOR SWORN AFFIDAVIT TO BRING FATHER-IN-LAW-DUE TO DEATH OF APPLICANT'S
MOTHER-IN-LAW**

- **Applicant's Documents**
Self-attested copies of the applicant's passport and Oman Resident Card must be submitted.
- **Financial Proof**
Salary certificate along with bank statements for the last 3 months must be provided.
- **Father-in-law's Passport**
Copy of the father-in-law's passport must be submitted.
- **Mother-in-law's Death Certificate**
Two copies of the death certificate must be provided.
- This application is applicable only when the father-in-law is residing in India.

Notes:

- **Validity of Documents**
Ensure that all passports and Oman Resident Cards are valid (not expired) at the time of submission.
- **Original Documents for Verification**
All original documents must be brought to the center for verification. Photocopies alone will not be accepted.
- **Mandatory Physical Presence**
All individuals required to sign the affidavit must visit the center in person and sign in front of the concerned officer.
