## **CHECK LIST FOR SWORN AFFIDAVIT TO BRING MOTHER-DUE TO DEATH OF APPLICANT'S FATHER**

- **Applicant's Documents**  
Self-attested copies of the applicant's passport and Oman Resident Card must be submitted.
- **Financial Proof**  
Salary certificate along with Oman bank statements must be provided
- **Mother's Passport**  
Copy of the mother's passport must be submitted.
- **Father's Death Certificate**  
Two copies of the death certificate must be provided.
- **This application is applicable only when the mother is residing in India.**

### **Notes:**

- **Validity of Documents**  
Ensure that all passports and Oman Resident Cards are valid (not expired) at the time of submission.
- **Original Documents for Verification**  
All original documents must be brought to the center for verification. Photocopies alone will not be accepted.
- **Mandatory Physical Presence**  
All individuals required to sign the affidavit must visit the center in person and sign in front of the concerned officer.
