**CHECKLIST SWORN AFFIDAVIT TOWARDS CHANGE OF NAME FOR MINOR CHILD (FOR NEWSPAPER

- **Applicant's Documents**

Copy of the applicant's passport and Oman Resident Card must be submitted.

- **Proof in Old Name**

At least two supporting documents showing the old name must be provided.

- **Proof in New Name (if available)**

At least two supporting documents showing the new name should be submitted, if available.

Notes:

- **Validity of Documents**

Ensure that all passports and Oman Resident Cards are valid (not expired) at the time of submission.

- **Original Documents for Verification**

All original documents must be brought to the center for verification. Photocopies alone will not be accepted.

- **Mandatory Physical Presence**

All individuals required to sign the affidavit must visit the center in person and sign in front of the concerned officer.
